Critical aviation safety topics

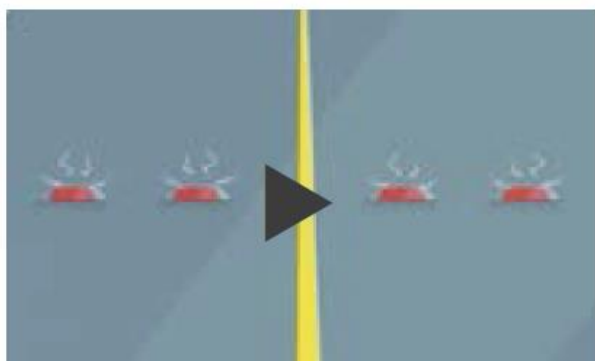

KEY SAFETY POINT

Never cross a lit stop bar, even if you have ATC clearance

KEY SAFETY POINTS

1. The **aircraft or vehicle causing the condition** must be **clearly visible** to pilot
2. The **aircraft causing the condition** in the clearance must be the **first one passing** in front of the other aircraft concerned
3. The **readback** of the conditional clearance **must always contain the condition**

Callsign Confusion

KEY SAFETY POINTS

1. Try **not to clip transmissions**
2. **Enunciate and emphasize digits, letters** and similar sounding words clearly
3. Always **pronounce numbers** in call sign **digit by digit**
4. Only abbreviate registration markings

KEY SAFETY POINTS

1. Safety related parts of all messages must be read back
2. **Readback must be complete and clear**
3. Always **make a full readback**
4. **Ask for confirmation if you doubt** the precise content of the transmission
5. Always **use correct and precise ICAO standard phraseology**
6. **Be wary of expectation BIAS**
7. **Consider workload** in critical flight phases **and time your message** accordingly

KEY SAFETY POINTS

1. **Never rush** a low visibility departure
2. **Maintain positional awareness**
3. If possible, **avoid doing checks and checklist while** the aircraft is **taxiing**
4. **If you have any doubts, stop the aircraft**, advise ATC, and resolve the doubt
5. Once you lined up, confirm you are departing from the correct runway
