Forging a Federation ready for challenges



Yesterday, IFALPA President Capt. Don Wykoff opened the 2012 Plenary following an insightful welcoming speech by Patrick Gandil, DGAC of the French Civil Aviation Authority. In addition to introducing the topics to be covered in the "State of Federation Report", Capt. Wykoff announced IFALPA's plans to move its head office to Montreal, the milestone of which is expected to occur in July when the expanded McGill St Office is due to open.

Proximity is everything

IFALPA's new location will be

in close proximity to both the ICAO, IATA, and ACI offices, which will put the organisation in the best position to move forward. "In addition to building a strong strategic plan, we must make a concerted effort to be technolog-

ically and industrially relevant around globe," he said.

Capt. Rene de Groot, Deputy President, reviewed priorities related to Industrial Committee, including Mutual Assistance, and interfacing with the Industrial Committee and alliance strategy. He called on pilots to unite and move forward together, developing structures that maximize our strengths and knowledge.

de Groot noted an increase in the Helicopter Committee's activity, especially by the pilots of the IPHPA. "Their pilots are eager to join IFALPA, which will provide them with a voice at ICAO."

Deficit slashed in 2011, reports Lypchuk



Meanwhile, EVP Administration and Finance, Capt. Rod Lypchuk commended the staff, executive board, and volunteers on their concerted effort to embrace the new budget procedure, which has enabled our organisation to stabilize. A policy which has seen 2010's deficit of GBP 229,000 slashed to GBP8,000 last year even as revenues fell by around GBP30,000.

As a result of these efforts as well as the income from Montreal International and the rental income from Interpilot House. Forecast is for the Federation's balance sheet to show an average surplus of GBP35,000 annually for the next five years.

His final remarks expressed his desire to see pilots leverage their power by organising at a national and international level in a responsible way.

"Today's pilot needs different skills than we used to – it takes a lot of work to reach the highest standards of the profession. It is a pilot's duty to remain humble," he said. "It's the secret to success. Concluding his remarks Fongen told delegates "The work I have done I have done for you my fellow pilots but also for selfish reasons - I got a lot out of it and had a lot of fun".

Dallel warns of Persian Gulf brain drain



Capt. Suhaiel Dallel, EVP AFI/MD, expressed concerns over mass immigration of pilots from African countries to the Persian Gulf. He argued that this "brain-drain" of pilots exiting the AFI region could have negative impacts on safety.

Recovery signs apparent in CAR SAM

Capt. German Diaz-Barriga, EVP CAR/SAM, noted that after a period of turbulence, the member associations within the region have stabilized or even become healthy. As the industry recovers, contracts and conditions continue to improve but Diaz-Barriga went on to caution that due to the cyclic nature of the industry, this continued improvement cannot be guaranteed. He pointed to a number of concerns facing the region's pilots, citing flight and duty time issues, open skies agreements, and a growing pilot shortage as evidence of this assertion.

Flight and duty times based in science, demands Nardy

EVP Europe SFO Francis Nardy made an encouraging call for strength at a time of economic uncertainly for the region. He also expressed his region's frustration with regards to pilot fatigue regulation. "It is important to establish one standard based on scientific principles relating to pilot fatigue, but who determines the validity of the science?" he asked.
